# Selling pressure near 1,080 pts zone

### **VN30** performance

The VN30 index formed the closing price at 1,068 pts. To be specific, MSN (-2.2%), VNM (-1.8%), GAS (-1.6%), VIB (-1.4%), and KDH (-1.4%) were top 5 index laggards. Relating to foreign trading activity, selling came back with net sell value was VND340bn, mainly driven by large sell orders on VNM, MSN, and HPG.

## VN30 Future chart: Selling pressure near 1,080 pts zone

Demand has increased strongly near 1,050 pts zone, confirming the valid rebound phase and increasing the tendency to retest 1,100 pts area. However, selling pressure is still strong near 1,080 pts zone which means the current intraday rebound could be faded as well as short-term range bound could take place. Major MAs on wider charts show no sign of upcoming valid market leg. On Hourly chart, the intraday rebound phase is paused but the instrument has high probability to enter the high volatile trading period. 1,050 pts zone is the demand zone for the rebound phase which has low probability to be broken in the short-term. Due to the favorable risk/reward ratio, traders could open the long positions after ATO session.

#### **Technical strategy**

Due to the favorable risk/reward ratio, traders could open the long positions after ATO session. Long VN30F2306 after ATO session and stop the loss when there is the closing price below 1,050 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




