# Selling pressure near 1,100 pts zone

### **VN30** performance

The VN30 index formed the closing price at 1,092 pts. To be specific, VIB (-3.2%), VPB (-2.0%), KDH (-0.2%), SSI (-3.2%), and GVR (-3.0%) were top 5 index laggards. Relating to foreign trading activity, selling pressure continued with net sell value was VND200bn, mainly driven by large sell orders on VNM, POW, and VRE.

## VN30 Future chart: Upward momentum is active

Demand has come back to the market, respecting the 1,050 pts level, forming the higher low. Higher high is confirmed due to the broken 1,080 pts area. On Daily chart, the instrument is traded above major MAs, signaling the stable bullish momentum. Major MAs on wider charts show the weakness of selling pressure. On Hourly chart, bullish momentum is stable which increases probability for the upward swing to continue. However, 1,100 pts zone is the strong barrier which means short-term range bound could take place. 1,050 pts zone is the demand zone for the rebound phase which has low probability to be broken in the short-term. Due to the favorable risk/reward ratio, traders could hold the captured long positions.

#### **Technical strategy**

Long positions on VN30F2306 should not be closed and stop the loss when there is the closing price below 1,050 pts level (Hourly chart).



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




