Impressive export volume in May

Impressive export volume in May

- Vietnam Steel Association (VSA) publicized the May steel production volume of 2.0mn tonnes, +3.1% mom, -19.8% yoy. We witnessed a significant drop for most steel products.
- The total consumption volume was significantly up 13.3% mom, but -0.2% yoy to 2.14mn tonnes.
- Breaking down domestic sale volume (1.3mn tonnes, -17.8% yoy), we witnessed a m-o-m increase in most products, except steel coils.
- The export volume was impressive with 822,657 tonnes, +51.9% yoy, +29.7% mom.
- Steel inventory as of end-May was at 1.15mn tonnes decreased slightly by 0.8% mom.
- The movements of raw material input prices were mixed the last 30 days: as of 14 Jun, iron ore was around USD107/mt (+7USD/mt), China hot roll coil (HRC) decreased to USD537/mt (-14USD/mt); Au hard coking coal decreased to USD220/mt (-15USD/mt).
- Based on quoted prices of Hoa Phat steel bar in May, the local prices of steel products were VND14.95Mn/tonne.

5M23 performance slumped

 Overall, Vietnam produced 10.2mn tonnes in the 5M22, -22.5% yoy. The total sale volume was slumped due to weak global demand (9.5Mn tonnes, -20.0% yoy).

Ratings and recommendation: Neutral on weak 2023F outlook

 We maintain our Neutral rating on Vietnam's steel sector due to the lack of sales volume growth, which might continue to hinder the market's business sales over the next months. Furthermore, the tepid economic growth could cast a shadow on the export performance.

Figure 1. Global HRC prices may bottom out in May







Figure 5. Export volume drove the total increase





Figure 2. Material input prices were mixed the last 30 days





Figure 4. Total consumption increased in May




