

Heading to 1,200 pts zone

VN30 performance

The VN30 index formed the closing price at 1,160 pts. Relating to foreign trading activity, supply surged with net sell value was VND370bn, mainly driven by large sell orders on STB, VNM, and VPB.

VN30 Future chart: Bullish extension phase

VN30F2307 keeps following the bullish swing, demand is stable and bullish momentum has shown no sign of weakness. The short-term range bound is ended due to the higher high and higher low pattern. However, the probability for minor correction is increased due to the overbought condition. The broken 1,140 pts level has turned around to be the intraday support level. On Daily chart, the instrument is traded above major MAs, signaling the stable bullish momentum and the bullish move is still the major move. Major MAs on wider charts show the stable of demand. 1,050 pts zone is the demand zone for the rebound phase which has low probability to be broken in the short-term, followed by 1,080-1,100 pts area. Intraday demand zone should be 1,140 pts area, followed by 1,110 pts zone. There is the tendency for the instrument to keep following the bullish leg during this trading week.

Technical strategy

Long positions on VN30F2307 should be held and stop the loss when there is the closing price below 1,140 pts level (Hourly chart).

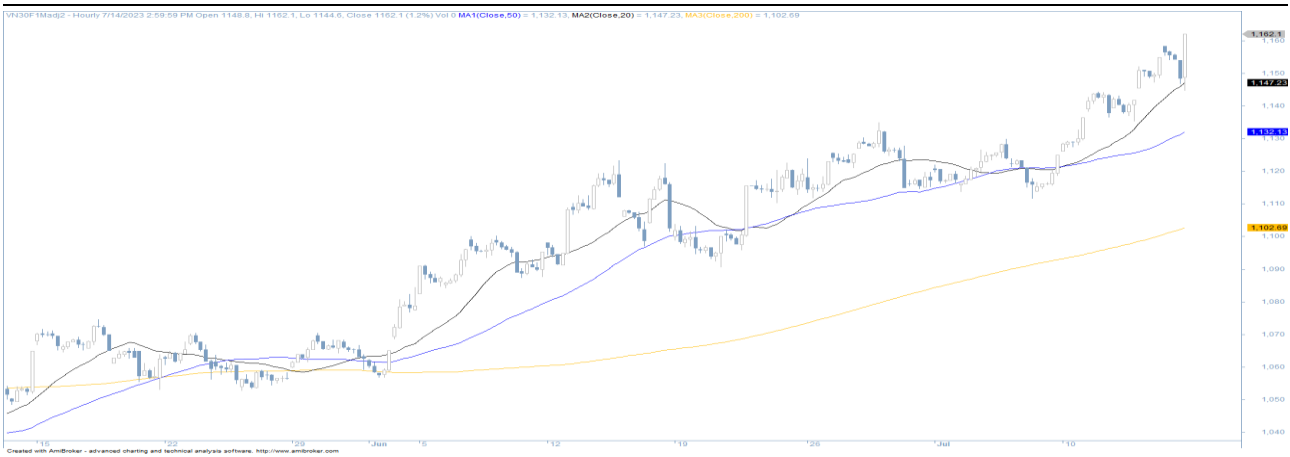

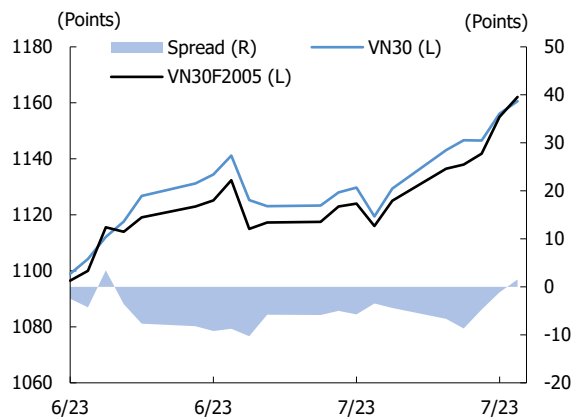

Figure 1. VN30 Generics hourly chart



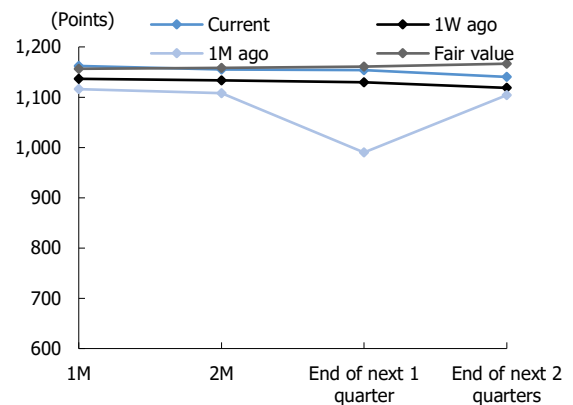

Figure 2. Basis spread



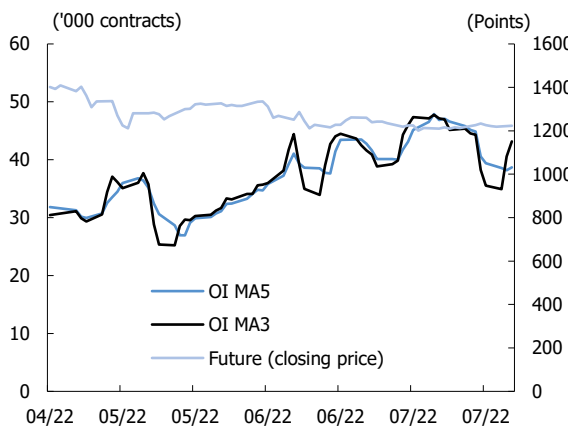

Figure 3. Future price curve



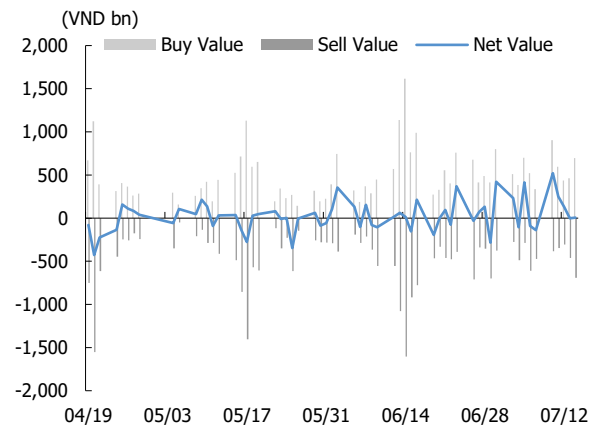
