Market commentary

High demand on Brokerage

Inflow across the market intensified significantly during the session, helping the stock market to experience a sharp rise day. In which, Brokerage was the most invested sector as almost shares soared to the ceiling price. Besides, Vietnam and the U.S. had just upgraded their relationship from Comprehensive Partners to Comprehensive Strategic Partners during President Joe Biden's visit.

At the close, the VNIndex rose by 1.78% to close at 1,245 pts while the VN30Index also gained 2.04% to 1,255 pts. Meanwhile, trading volume reached 919 million shares/VND22,926bn, down 15%/ 11% respectively, from the average of the last five sessions.

Foreign investors reversed to net buying, with more than VND137bn, focusing on PDR, SSI, VIX with net values of VND72bn, VND71bn, and VND61bn, respectively. In contrast, net selling concentrated on VIC, KBC, and STB with VND96bn, VND73bn, and VND53bn, respectively.

Banking was the leading market driven by MBB (+2.67%), STB (+2.37%), TCB (+2.17%), SHB (+2.03%), VPB (+1.83%), ACB (+1.79%), HDB (+1.75%), VCB (+1.58%), TPB (+1.32%), SSB (+1.30%), CTG (+1.25%), BID (+1.08), and VIB (+0.99%).

Brokerage was the most notable bright spot during the session as almost tickers not only increased strongly but also soared to ceiling prices, such as MBS (+10.00%), SHS (+9.04%), BSI (+6.99%), AGR (+6.98%), CTS (+6.94%), FTS (+6.89%), SSI (+6.87%), VND (+6.84%), VIX (+6.74%), VCI (+6.32%), and HCM (+5.60%).

Real Estate had a good situation among PDR (+6.48%), DXG (+5.19%), DIG (+4.14%), VRE (+2.79%), KBC (+2.64%), NLG (+2.41%), NVL (+2.20%), VIC (+2.03%), VHM (+1.90%), IDC (+1.46%), KDH (+1.15%), BCM (+1.13%), and SSH (+0.16%).

Demand pushed Consumer Staples and Retail shares up, including DGW (+3.33%), VHC (+2.58%), MWG (+2.39%), MSN (+1.76%), FRT (+1.76%), VNM (+1.01%), SAB (+0.84%), and QNS (+0.40%). Besides, Steel tickers also outperformed the benchmark index, such as NKG (+3.57%), HPG (+2.68%), and HSG (+2.58%).

Cash flowed into Oil & Gas thanks to PVS (+2.79%), PVC (+2.67%), PVD (+1.73%), POW (+1.57%), GAS (+1.28%), BSR (+0.94%), and PLX (+0.38%). In addition, GVR (+4.37%), DHG (+3.01%), VJC (+2.93%), FPT (+1.54%), DGC (+1.43%), and BVH (+0.66%) also closed in the green territory.

On the other side, DPM (-0.62%), MCH (-0.37%), and KDC (-0.30%) lost at the end.

The stock market increases strongly during the session with liquidity at a normal level, showing a positive signal. The uptrend is still intact, however, the downside risk at the important resistance zone of 1,240-1,250 pts may appear again. Therefore, investors should stand aside and observe the next movements of the market. The next sessions, if the VNIndex successfully surpassed the 1,250-pts threshold with high liquidity, investors could open again long positions.
