Rebound phase is needed

VN30 performance

The VN30 index formed the closing price at 1,166 pts. Relating to foreign trading activity, supply surged with net sell value was VND230bn, mainly driven by large sell orders on CTG, HPG, and VIC.

VN30 Future chart: Volatile trading period

Selling pressure is increasing, pushing the VN30F2310 to close below major MAs, confirming the short-term correction period and the bullish swing is completely paused. Major MAs are sloping downward, implying the active bearish momentum and the bullish move is completely ended. Selling pressure near 1,220 pts zone is active which needs time to fully consume. The bullish swing is completely paused and long positions are not valid during this period. Nevertheless, oversold condition is reached as well as volatile period is active. New short positions are risky and selling point carries bad risk/reward ratio. Open interest stays below 50,000 contracts, implying the slowdown of bearish momentum. Thus, traders should stay on the sidelines and wait for the favorable trading point.



Figure 1. VN30 Generics hourly chart





Figure 2. Basis spread





Figure 4. Open interest pattern




