

# **CTCP Vincom Retail (VRE)**

# Bứt phá và tăng tốc

CTCP Vincom Retail (VRE) đã công bố báo cáo tài chính Q3/2022. Dưới đây là một số điểm đáng chú ý.

# Doanh thu vượt trội trong Q3/2022

- Phục hồi mạnh mẽ sau giai đoạn giãn cách do COVID-19, doanh thu của VRE trong Q3/2022 tăng mạnh 2,000 tỉ đồng (+154.7% n/n). Biên lợi nhuận gộp trong Q3/2022 đạt 794 tỉ đồng (+3,156% n/n). Tỷ suất lợi nhuận gộp cải thiện đáng kể từ 17% trong Q3/2021 lên 52% trong Q3/2022 do giảm tiền thuê nhằm hỗ trợ các nhà bán lẻ trong đợt bùng phát Covid-19 vào Q3/2021.
- Trong Q3/2022, doanh thu cho thuê bất động sản đầu tư đóng góp tới 92% tổng doanh thu, tăng 152% n/n lên 1,8 nghìn tỷ đồng nhờ sự phục hồi hoạt động của các nhà bán lẻ.
- Hoạt động kinh doanh bất động sản trong Q3/2022 cũng ấm lên khi tăng 568% lên 136 tỷ đồng, đóng góp 7% vào tổng doanh thu. Trong khi đó, doanh thu từ dịch vụ khác (2% tổng doanh thu) giảm 18% n/n xuống 32 tỷ đồng.
- Lũy kế 9T22, doanh thu tăng 15% n/n đạt 5,2 tỷ đồng và LNST tăng 63% n/n lên 1,9 tỷ đồng, tương ứng hoàn thành 65% và 80% kế hoạch
- Số lượt khách ghé thăm vượt 41% n/n và đạt 85-95% mức của Quý 3/2019 trước đại dịch COVID-19. VRE kỳ vọng đạt tỷ lệ lấp đầy 85% trong Q4/2022.

# Kế hoạch kinh doanh trong giai đoạn 4Q22F-2023F

- Quý 3/2022, Trung Nguyên Legend khai trương 10 cửa hàng trong chuỗi Vincom. Uniqlo sắp khai trương thêm 3 cửa hàng tại Vincome Center Bà Triệu, Vincom Mega Mall Royal City và Vincom Center Trần Duy Hưng trong 4Q22F.
- Để chào đón mùa sale cuối năm, VRE đang phối hợp với các nhãn hàng chuẩn bị cho chương trình Black Friday & lễ giáng sinh được chờ đợi nhất trong năm.






Biểu đồ 1. Biến động doanh thu



#### Biểu đồ 3. Dòng doanh thu Q3/2021 và Q3/2022






## Đồ thị 4. Số lượng siêu thị Vincom
